

**INCREASE IN LEVEL OF ACCEPTANCES**

**1. INTRODUCTION**

The Board of Directors of Frencken Group Limited ("**Frencken**") refers to the announcement dated 12 October 2012 (the "**Level of Acceptances Announcement**") made by DBS Bank Ltd., for and on behalf of Frencken in relation to the voluntary conditional offer (the "**Offer**") for all the issued and paid up ordinary shares in the capital of Juken Technology Limited ("**Juken**") (excluding issued and paid up ordinary shares held by Juken as treasury shares) (the "**Juken Shares**"), other than those already owned, controlled or agreed to be acquired by the Offeror in accordance with Rule 15 of the Singapore Code on Takeovers and Mergers.

All capitalised terms used and not defined herein shall have the same meanings given to them in the Level of Acceptances Announcement, unless otherwise expressly stated or the context otherwise requires.

**2. INCREASE IN LEVEL OF ACCEPTANCES**

Paragraph 2 of the Level of Acceptances Announcement sets out details of the Acceptances received by the Offeror as at 5.00 p.m. on 12 October 2012.

Pursuant to the Acceptances received, as set out in the Level of Acceptance Announcement, Frencken now holds 93.74% of the issued share capital of Juken<sup>1</sup>.

Further information on the Offer, including details on the Acceptances, can be found in the Level of Acceptances Announcement.

The aggregate value of the consideration, factors taken into account in arriving at it, how it will be satisfied, terms of payment, and value of the Juken Shares to be acquired pursuant to the Offer, are set out in paragraphs 4.7, 4.8, 3.1(b) and 4.1 respectively of the circular dated 8 August 2012 addressed to the shareholders of Frencken.
